Guidelines for the Ongoing Maintenance of the ESHC

The ESHC is valid for three years and is contingent upon continuing professional development (CPD). Holders of the ESHC will be required to provide a verifiable record of CPD, which CEPE (the Committee on Educational Programmes in Europe) has set at 60 Credit Points (CPs) over three years. Once validated, a new Certificate will be issued on payment of £42 / 50 Euro.

DEFINITIONS

Continuing Professional Development (CPD): ESHC is valid for three years and is contingent upon continuing professional development (CPD). Holders of the ESHC will be required to provide a verifiable record of CPD, which CEPE (the Committee on Educational Programmes in Europe) has set at 60 Credit Points (CPs) over 3 years.

Credit Point (CPs): As a proof of CPD, ESHC Holders should collect Credit Points (CPs) by attending hypnosis events (lectures, workshops, courses, symposia, and congresses etc.). You can see above ESHC CPD Guidance Notes for further information about how to collect CPs for CPD.

ESHC RENEWAL REQUIREMENTS

I) One should meet ESHC Requirements in order to apply for the renewal of her or his ESHC. For further information please see ESHC Requirements for the Adjunct Use of Hypnosis and for the Modality Use of Hypnosis (Attachment 2).

II) For the renewal application of ESHC, one should be **a member of an ESH Constituent Society (CS).** This is an important criterion for ESH since being a member of an ESH CS is a good indication of professional interest, dedication and enthusiasm to use hypnosis in accordance with ESH standards.

III) To be eligible for the renewal application of ESHC, one should collect minimum **60** *CPs in the last* **3** *years* as a proof of CPD in the field of hypnosis.

WHAT TO DO TO COMPLETE THE ESHC RENEWAL APPLICATION

- *I)* The ESHC Renewal Applicant should fill in **Attachment 4: ESHC Renewal Form**.
- *II)* The applicant should prepare Attachment 5: ESHC CPD Record Sheet along with the copies of the relevant Certificates to show that she or he has collected at least 60 Credit Points (CPs) over 3 years.
- **III)** The applicant should submit Attachment 4, Attachment 5 and the relevant documents (certificates, diplomas etc.) to her or his **CS or ATS**. The CS or ATS should **stamp** all the forms and **send** by email all the attachments and relevant documents to **ESH Central Office** for the records of ESH.
- **IV)** The applicant should send ESHC **renewal fee** to ESH Central Office so that the Evaluation and Approval Process could start.
- **V)** If ESHC renewal application is **approved**, then ESH Central Office will **renew** ESHC <u>upon receival of the renewal fee</u>, the renewal application form and all the relevant documents (all attachments, certificates, diplomas etc.).
- *VI*) *ESH Central Office will send ESHC to the applicant's postal address.*
- **VII)** ESHC is valid for **three years** and is contingent upon continuing professional development. Holders of the ESHC will be required to **renew** their ESHC by providing a verifiable record of **60 Credit Points over 3 years**.
