DEFINITIONS

Hypnosis as an Adjunct to a Professional Field: It is the adjunct use of hypnosis as support to an existing set of professional skills in Medicine, Dentistry and Psychology.

For example: Adjunct use of hypnosis by Medical Doctors, Dentists, Clinical and Medical Psychologists, and also by Psychotherapists who have a legally registered title in their own countries.

Hypnosis as a <u>Modality</u>: It is the use of hypnosis within a comprehensive psychotherapeutic modality based on the therapeutic use of trance and suggestions integrating depth-psychological, behavioural, systemic and solution-oriented approaches.

Modality use of hypnosis is recognized by ESH for Countries where psychotherapy and hypnosis-psychotherapy are legal entities with prescribed training criteria.

For example: Modality use of hypnosis in hypnosis-psychotherapy.

European Society of Hypnosis Certificate (ESHC): ESHC is a certificate given by European Society of Hypnosis (ESH) as a proof of clinical expertise, experience, and continuous professional development in the clinical applications of hypnosis.

ESHC Training Criteria for the Adjunct Use of Hypnosis: Minimum 200 hours of training and minimum 2 years of clinical work experience, in other words the completion of Level 1-Basic Training and Level 2-Advanced Training, is required to be able to apply for ESHC for the adjunct use of hypnosis.

Please see the ESHC Requirements for the Adjunct Use of Hypnosis in Attachment 2 for further details.

ESHC Training Criteria for the Modality Use of Hypnosis: Minimum 2000 hours of academic Hypno-Psychotherapeutic Training is required to be able to apply for ESHC for the modality use of hypnosis. Hypno-Psychotherapeutic Training will only be acceptable by ESH only in the countries where Psychotherapy and Hypno-Psychotherapy are legally registered titles and are recognized by legal authorities.

Please see the ESHC Requirements for the Modality Use of Hypnosis in Attachment 2 for further details.

Constituent Society (CS): It is the national European Society in the field of hypnosis that meets ESH membership requirements and that is approved by ESH COR as ESH CS.

Accredited Training Society (ATS): It is the ESH CS accredited by ESH to give hypnosis training.

ACCREDITED TRAINING SOCIETY (ATS) REQUIREMENTS

I) Applicant: Only ESH Constituent Societys (CSs) can apply to become an ATS or to renew their accreditation as an ATS.

This is an important criterion for ESH since ESH CSs are representatives of ESH in their own countries that stand for the professional application, training, research and recognition of hypnosis in accordance with ESH standards.

II) Training To Be Provided: The ATS should provide minimum 100 hours of Level 1- Basic Training that includes minimum 50 hours of basic theoretical hypnosis training & minimum 50 hours of supervision in hypnosis applications.

If a member of a CS or ATS wants to apply for ESHC, she or he should complete Level 2- Advanced Training which includes Further Hypnosis Training and Clinical Work Experience.

Further Hypnosis Training should be minimum 100 hours in hypnotic applications and techniques. Further Hypnosis Training can include courses, conferences, workshops and online learning etc.

Clinical Work Experience in the field of hypnosis should be at least 2 years. The confirmation (stamp and signature) of the ESHC applicant's <u>CS or ATS</u> on the ESHC Application Form will be sufficient as a proof of the completion of min 2 years Clinical Work Experience.

It is possible for the ATS to provide a part of or all of the Further Hypnosis Training. On the other hand, providing Further Hypnosis Training is <u>not an obligation for the ATS</u>.

It is the responsibility of the ESHC applicant to complete Further Hypnosis Training by attending an ATS events and/or by attending courses, conferences, workshops and online learning etc. in the field of hypnosis. However, the ESHC applicant should get her/ his <u>CS's or ATS's approval</u> for Further Hypnosis Training taken somewhere other than an ATS. Please see ESHC Requirements in Attachment 2 for further information.

III) Training Program Content: In order to apply to become an ATS or to renew accreditation as an ATS, another requirement is to have a proper hypnosis training program content. Attachment 6: ESHC Training Guidelines could be used as a guideline for the content of the training program.

IV) Trainee Criteria: Only the trainings given to qualified health professionals could be accredited by ESH as ESHC Training. Also, only a qualified health professional who completed successfully ESHC Training given by an ATS can become eligible to apply for ESHC.

A qualified health professional is a person who is authorized by legal authorities to treat clients/ patients.

Medical Doctors, Dentists, Clinical and Medical Psychologists and Psychotherapists are the examples of qualified health professionals who could apply to be an ESHC Holder.

- **V) Trainer Criteria:** The Trainer Criteria and Trainer CVs should be submitted for ESH approval to apply to become an ATS or to renew the accreditation as an ATS.
- **VI)** Supervisor Criteria: The Supervisor Criteria and Supervisor CVs should be submitted for ESH approval to apply to become an ATS or to renew the accreditation as an ATS.

WHAT TO DO TO COMPLETE ATS APPLICATION OR RENEWAL

- I) The applicant CS meeting the ATS Requirements should fill in Attachment 7: ESHC ATS Application & Renewal Form.
- II) The applicant CS should submit by email Attachment 7 and the Society's Training Program Content, Trainee Criteria, Trainer Criteria & Trainer CVs, and Supervisor Criteria & Supervisor CVs to ESH Central Office.
- **III)** If ATS application is **approved** by ESH, then ESH Central Office will **issue** ATS Certificate
- *IV) ESH Central Office will send ATS Certificate to the CS's postal address*.
- V) ATS Certificate is valid for **three years** and ATSs are required to **renew** their accreditation by meeting ATS requirements, and by submitting Attachment 7 and the Society's Training Program Content, Trainee Criteria, Trainer Criteria & Trainer CVs, and Supervisor Criteria & Supervisor CVs to ESH Central Office every 3 years.
